Opening Eucharist on Thursday, October 6, 2016

Clergy, lay delegates, alternates and visitors gathered at St. John's Cathedral in Denver, Colorado on October 6, 2016 at 7:00 pm for the opening Eucharist with the Right Rev. Robert J. O'Neill of the Diocese of Colorado as preacher and celebrant. In his remarks Bishop O'Neill spoke of the all-important work to be performed by the delegates to the convention. A joyous Eucharist celebration was followed by a reception hosted by St. John's Cathedral. The offering collected at the service was designated for Hurricane Relief in Haiti.

Friday, October 7, 2016

Morning General Session #1

The Rev. Lyn Burns opened the session with prayer. Bishop O'Neill welcomed and thanked the attendees for coming. He thanked the parishioners of St. John's Cathedral for their hospitality at last night's Eucharist. The Bishop called the 129th Annual Convention of the Episcopal Diocese of Colorado to order at 8:35 am. He encouraged people to attend the workshops, participate in the worship and to be nourished and fed by the experience. The Bishop appointed Rick Parker to be Secretary of Convention and the Diocesan Chancellor, Lawrence R. Hitt II (Larry) to be Parliamentarian of Convention. The appointments were ratified by the convention.

Without objections, the following persons were appointed by the Bishop to fill the Committees of Convention.

Irene Kornelly was appointed Assistant Secretary of Convention.

Mike Orr, the Rev. Becky Jones and the Rev. Becky Brown were appointed to the Committee to Approve Minutes for this Convention.

The Rev. Steve Baird was appointed to be Chair of the Committee for the Conduct of Nominations and Co-Chair, along with The Rev. Rhoads Hollowell, of the Committee for the Conduct of Elections.

The Rev. Todd Sorensen was appointed to be Chair of the Committee for Legislation and Resolutions with Larry Hitt as a consultant.

The Secretary of Convention reported that a Quorum was present of both the Clergy and Lay Orders for this Convention.

The Bishop requested that the Parliamentarian report on the Proposed Rules of Convention. Chancellor Lawrence (Larry) R. Hitt, II reminded delegates that rules had been posted to the Convention website. He then summarized the rules and highlighted some important details. The Bishop moved for the adoption of the Rules of Convention as presented by the Chancellor. The motion was passed by voice vote.

The Secretary of Convention moved that the agenda, included in delegate packets, be accepted as printed. The motion was so ordered.

The Secretary of Convention stated that the Committee to Review the minutes of the 128th Convention had reviewed and approved the minutes of last year's convention and that they had been posted on the Convention web page. He submitted those minutes and asked that the Chair receive them. The motion was so ordered.

The Bishop declared that the 129th Convention of the Diocese of Colorado was organized for Business.

Welcome & Introductions:

The Bishop warmly welcomed our 10 new Episcopal Service Corps Interns: Mariana Diaz, Rebecca Hannigan, Esther Ou, Veronica Farrell, George Monroe, Evan Brock, John Evans, Collette Newcombe, Sara Sweeney and Elizabeth Markman.

The Bishop also thanked Michelle Vieira and Annie Croner who organized all the volunteers who will helping to make everything run smoothly for the next 2 days. Volunteers were from St. Timothy's, Centennial; All Saint's, Loveland; St. John's, Granby; St. Barnabas, Denver; St. Gregory's, Littleton; St. Andrew's, Denver; Christ Church, Aspen; St. Charles, Ft. Morgan; St. Peter and St. Mary, Denver; St. Aidan's, Boulder and St. John's Cathedral

The Bishop introduced The Rev. Canon Ruth Woodliff-Stanley and invited her to introduce new clergy to the diocese.

New Clergy to the Diocese

The Rev. Charlie Brumbaugh was born and raised in the Diocese of Southern Ohio and celebrated his 30th ordination anniversary this summer. After realizing that the time was ripe for a new adventure he and his wife Anne were led to, and embraced by, St. John the Baptist Episcopal Church in Summit County.

The Rev. Krista Dias was called to Chapel of Our Saviour in Colorado Springs, after serving as Curate at Christ Church in Short Hills, NJ. She grew up in Boulder, then spent thirteen years in the New York City area dancing professionally, teaching preschool and serving as a youth minister.

The Rev. Greg Foraker was called to join in ministry at St. Luke's in Fort Collins in November, 2015, serving as Associate Rector for Leadership Development and Vocational Discovery. He comes from the Diocese of Arizona where he served at St. Philip's in the Hills in Tucson.

The Rev. Steven Hagerman is serving as partnership vicar for St. Charles, Fort Morgan and Prince of Peace, Sterling after 34 years of parish ministry, most recently in the Diocese of Maryland.

The Rev. Robert Hart currently is interim rector of St. Thomas, Park Hill, Denver. Bob is a retired priest who came to Colorado when his wife, Becky, was made curator of modern and contemporary art at the Denver Art Museum in August of 2015. Bob retired from All Saints, Pontiac, MI.

The Rev. Deborah Hanson lived and worked in Jackson, Mississippi, for approximately 30 years, before moving to Colorado recently. She has been a registered nurse for over 43 years. Deborah was ordained a Deacon in 2015 and served the Diocese of Mississippi as the Chairperson for the Honduras Medical Mission, and in Bridges Out of Poverty work. She and her family are in the process of building and developing Landmark, a Community of Memory Care homes in Lafayette, CO. The Rev. Canon Evelyn Hornaday joined St. John's Cathedral on September 1 as Canon for Cathedral Life. A priest trained in interim ministry, she comes to the Diocese of Colorado from St. Peter & All Saints, Kansas City where she guided the consolidation of two parishes, the redevelopment of their financial structures, and the sale of the unused property, all the while managing the pastoral and liturgical needs of the people in both parishes.

The Rev. Wendy Huber, ordained in the Diocese of Texas, served small parishes in rural Texas. Rev. Huber was trained first as an attorney specializing in mediation and reconciliation and second as a priest. She came to Colorado for: a love of Jesus; to be close to family; flyfishing; mountains; and an opportunity to serve as rector at St. Barnabas in Glenwood Springs.

A Houston, Texas native, the Very Rev. Ron Pogue spent the last seven of years serving in interim ministries all across the country, most recently at Saint John's Church in Jackson Hole, Wyoming. He was called to Denver to serve as Interim Dean of Saint John's Cathedral.

The Rev. Debbie Metzgar Shew began as rector at St. Mark's in Durango on July 1st, where she was thrilled to have landed with her husband David and 3 of the 4 kids they have between them. In their wildest dreams, they'd never have imagined that all 6 "Atlanta Shews" would end up in CO, and in the midst of such breath-taking beauty.

The Rev. Becky Tinnon is canonically resident in Hawaii and moved to Denver to be closer to family and the beautiful Colorado mountains. She is beginning a PhD in psychology this fall. She currently works with embedded behavioral health at Ft. Carson and hopes to explore the connection between spirituality/psychology and how that impacts our faith.

The Rev. Mike Tinnon retired from the United States Air Force in 2010 having served over 28 years as an Army and Air Force chaplain. He served in the Diocese of Hawaii (his canonical residence) and the Diocese of Los Angeles. He and his wife Becky moved to Colorado Springs in August 2015. He currently serves as the Interim at Peace in Christ Episcopal-Lutheran Ministry, Elizabeth, Colorado.

The Rev. Brendan E. Williams, OSB, was called in July to serve as Curate at Grace and St. Stephen's in Colorado Springs. He is a graduate of The Church Divinity School of the Pacific in Berkeley, California, and comes to Colorado from the Diocese of California (San Francisco Bay Area). He is also a Benedictine monastic, and prior of The Community of St. John Cassian, a recently founded traditional Benedictine religious order.

The Rev. Jeremiah Williamson began his ministry as the Rector of Grace and St. Stephen's in Colorado Springs on Ash Wednesday. After serving as the Rector of St. Andrew's in Toledo, Ohio for seven years, Fr. Jeremiah felt called to join the good people of Grace and St. Stephen's for the next exciting chapter in their ministry.

The Bishop asked all in attendance to take a moment to prepare ourselves for morning worship. Worship opened with songs, readings from scripture and prayers.

The Rev. Canon Ken Malcolm introduced the keynote speaker, the Rev. John Bell.

First vote for General Convention Deputies

The Chair recognized the Rev. Rhoads Hollowell and the Rev. Steve Baird, Co-Chairs of the Committee for the Conduct of Elections to explain the rules and prepare the Convention for the first ballot for deputies to General Convention. The rules for the conduct of election were available to all delegates in their informational packet.

Volunteers and the Staff of the Office of the Bishop collected the ballots. They were given to Rhoads and Steve for computation by the tellers away from the Convention floor. During the reading of the voting instructions, Zoe Cole, St. Luke's, Denver, rose to the microphone and asked that the information in the delegate packet be corrected to indicate that she is a member of St. Luke's Church in Denver and not St. Andrew's in Denver.

Video #1

The Rev. Canon Ken Malcolm introduced the first video from St. George's Church, the Rev. Ali Lufkin in Leadville. The video talked of bringing the Anglo and Latino communities at St. George's under the Gospel of the Good News of Jesus Christ.

The Bishop requested that we all take a few moments to prepare for worship. Rev. John Bell continued with his stories of the Bible.

Faith Formation and Cathedral Ridge

Prior to introducing the Rev. Canon Ken Malcolm, the Bishop announced that the offering taken at the Eucharist for Hurricane Relief in Haiti equaled \$5,750.53. Contributions can still be made to this fund.

The Bishop introduced the Rev. Canon Ken Malcolm, Elizabeth Gallegos, Tate Fox, Ann Fleming, and the Rev. Brook Keith to talk about Cathedral Ridge and to update the delegates on fundraising efforts for Cathedral Ridge.

Missioner for Advocacy and Social Justice

The Bishop introduced the Rev. Canon Rebecca Crummey, Missioner for Advocacy and Social Justice to talk about the Episcopal Service Corps. Two interns for ESC, Mariana Diaz and John Putnam told their stories as to how they came to be a part of ESC.

Bishop's Cross

Bishop O'Neill announced that he was awarding the Bishop's Cross to Anita Sanborn in honor of her untiring work as the head of the Colorado Episcopal Foundation. Anita will be retiring from this position in December 2016. Her presence will be missed.

Video #3

The Bishop introduced Daniel Coffey and Jesaia Lemke to talk about the video about Calvary Episcopal Church in Golden. Calvary provides a "Lunch 'N' Learn" program every week where students from the Colorado School of Mines can have a "free" lunch provided by parishioners, meet with other students and enjoy the companionship of the parishioners. Afternoon Break was taken from 3:55 pm until 4:15.

GENERAL SESSION # 3

Bishop O'Neill called the Third Session of the 129th Convention of the Episcopal Diocese of Colorado at 4:15 pm.

The Bishop recognized the Rev. Kim Seidman and Mr. Rick Parker to read and explain the proposed revisions to the Constitution from the 78th General Convention. These revisions are now subject to a second vote at the 2018 General Convention before they can take effect, if passed.

B011: Amend Article II.7

Resolved, That the Constitution of the General Convention (2012) Article II.7 is hereby amended to read as follows:

Sec. 7. The House of Bishops may elect a Bishop Suffragan who, under the direction of the Presiding Bishop, shall be in charge of the work of persons of this Church who serve as chaplains in the Armed Forces of the United States, and such other agencies as may be specified by the Presiding Bishop. The Bishop Suffragan so elected shall be ordained and consecrated and hold office under such conditions and limitations other than those provided in this Article as may be provided by Canons of the General Convention.

D003: Amend Article V

Resolved, That Article V, Section 1 is amended to read as follows:

A new Diocese may be formed, with the consent of the General Convention and under such conditions as the General Convention shall prescribe by General Canon or Canons, (1) by the division of an existing Diocese; (2) by the junction of two or more Dioceses or of parts of two or more Dioceses; or (3) by the erection into a Diocese of an unorganized area evangelized as provided in Article VI. The proceedings shall originate in a Convocation of the Clergy and Laity of the unorganized area called by the Ecclesiastical Authority for that purpose; or, with the approval of the Ecclesiastical Authority, in the Convention of the Diocese to be divided; or (when it is proposed to form a new Diocese by the junction of two or more existing Dioceses or of parts of two or more Dioceses) by mutual agreement of the Conventions of the Dioceses concerned, with the approval of the Ecclesiastical Authority of each Diocese. After consent of the General Convention, when a certified copy of the duly adopted Constitution of the new Diocese, including an unqualified accession to the Constitution and Canons of this Church, shall have been filed with the Secretary of the General Convention and approved by the Executive Council of this Church, such new Diocese shall thereupon be in union with the General Convention.

Report of the Committee on Nominations & Elections

Standing Committee Regional Representatives

The Bishop recognized the Rev. Steve Baird, Chair of the Committee of Nominations and Co-Chair of Conduct of Elections to report on the nominees for regional representatives to the Standing Committee.

The Rev. Steve Baird reported that the nominees for Regional Representatives to the Standing Committee are:

The Rev. Peter Floyd, rector of St. Michael's, Colorado Springs, to be elected as clergy representative, Sangre de Cristo Region, to a term expiring 2021

The Rev. Nature Johnston, rector of Nativity, Grand Junction, to be elected as clergy representative, Southwest Region, to a term expiring 2021

Bob Morse, member of St. John's, Boulder, to be re-elected to be elected as lay representative, Front Range Region, to a term expiring 2021

Jan Johnson, member of St. Peter's, Basalt, to be elected as lay representative, Northwest Region, to a term expiring 2021

The Bishop called for all those in favor of the nominees for regional representatives to the Standing Committee say aye, opposed no. The nominees were elected.

The Rev. Scott Turner expressed his thanks to the retiring members of the Standing Committee: The Rev. Leigh Waggoner, Southwest, Clergy; Caroline Hollowed Northwest Lay; The Rev. De Freeman Sangre de Cristo Clergy.

Disciplinary Board

The nominees for a full term on the Disciplinary Board to expire December 31, 2019, are: The Rev. Bonnie Spencer for re-election to a 2-year term; The Rev. George Berlin, St. Philip and St. James, Denver; The Rev. Gary Brower, Chaplain to University of Denver; Dr. Carol Gerard, St. John the Baptist, Breckenridge.

Since no other nominations were submitted prior to the deadline, the Bishop entertained a motion to elect these people to the Disciplinary Board by acclamation. The motion carried.
