Emergency Response Actions and Contacts

This Resilience Plan (hereafter "the Plan") has been developed to document plans and options for St. John's response in an emergency:

- To mitigate the damage to St. John's community's buildings and belongings;
- To be able to resume the business of the church as soon as possible post-disaster;
- To support our parishioners in times of crisis; and
- To assist to our vulnerable neighbors after an emergency.

The Plan addresses scenarios which could reasonably impact the St. John's facility and community. The intent is to plan how we would respond, but recognize that each emergency will be unique and requires specific responses as the needs are identified. The table below identifies the top level emergencies considered. Detailed response descriptions follow the table.

Risk Assessment

A Risk Assessment Identifies likely emergency scenarios impacting St. John's or Community

- What disasters might St. John's congregation in the future?
- What emergencies might arise at St. John's church or other location?

Historically, Eastern Grand County has experienced only one serious emergency event; a terrorist with a self-made "tank" which was used to destroy many buildings in the Granby area. Although the area is a candidate for floods and fires, nothing catastrophic has occurred in recent history. The St. John's facility, in particular, sits on a hill over Granby and is therefore unlikely to be affected by forest fire or flood. The Cranmer Chapel, in the middle of Winter Park, and could be affected by flood and as an old facility could be impacted by fires.

Three general emergency scenarios have been identified for consideration:

- 1. A medical emergency in either St. John's or Cranmer Chapel;
- 2. An evacuation situation requiring evacuation of the local community; and
- 3. An emergency situation in the local communities in which St. John's, Cranmer Chapel, and skilled parishioners could support victims, emergency responders, or emergency recovery.

Medical Emergency in Facility

The action in this event requires a quick determination of the extent of the emergency, but the general response is for anyone in the area is dial 911.

Evacuation of the Community

This event requires both emergency response and emergency recovery.

If time permits, the St. John's "Evacuation Kit" material is collected by the Disaster Coordinator, or alternate, and removed from the building: The kits for St. John's and Cranmer Chapel include:
