Proceedings of the 134th Annual Convention The Episcopal Church in Colorado Living Like We Pray

October 7-9, 2021 A Statewide Virtual Event

Opening Concert: Thursday, October 7, 2021 via Facebook and hosted by Grace and St. Stephen's, Colorado Springs

Lay delegates, clergy, alternates, and visitors participated remotely in the opening Concert for the Human Family, a collaboration featuring pianist and composer Kory Caudill and inspired by the Prayer for the Human Family in the Book of Common Prayer. The virtual participants were welcomed by the Rev. Jeremiah Williamson, Rector, and the Rt. Rev. Kimberly Lucas, Bishop of Colorado. Convention Keynote Address: Friday, October 8, 2021 Via Zoom Webinar

The Rt. Rev. Jennifer Baskerville-Burrows, Bishop of Indianapolis presented the keynote address. Bishop Baskerville-Burrows was the first female African-American Diocesan Bishop in the church.

Bishop Jennifer described the challenges that create anxiety in the church: pandemic, turmoil, climate change, and the loss of those who are not coming back. We live like we pray. We live our promises to God and one another. She shared her story of discovering the Episcopal Church and her call to ordination, and urged those attending to think about their story and how they came to be part of the Church.

Formation is ongoing for each of us. There is a deep hunger for real, meaningful, transformative community where a person can be known and loved with all their quirks. The world is being reshaped by forces that seem beyond our control. We need to reshape our church and community like we mean it. We must invite all to be fully part of our community. If your bishop is giving you permission to give up some things to better follow Jesus, believe her. Let us get out there where people are hungry and lonely and desperate to gather. Make room to get out to them, while you live your baptismal convenient. Live like you pray, and we will get there.

Joined by Bishop Kym for a moderated discussion, Bishop Jennifer shared details about her own personal journey, what made her fall in love with the Episcopal Church, and her hopes for the future. Now is the time when hierarchies are flattening and we are looking at new ways to think about old challenges. There is power in sharing our stories. When asked what a typical church needs to let go of, Bishop Jennifer noted that is a hyper-local question. When returning, we must approach the building as if we have never been there before. What is the neighborhood like? How is the church part of it?

The evening concluded with Compline, led by three members of the Daughters of the King from Colorado, Nancy Severin, Marlene Stroud, and Morgan Harrower.

General Session: Saturday, October 9, 2021 via Zoom Meeting open to all delegates

The delegates participated in an online Morning Prayer service, hosted by Loren Pierce-Coleman, St. George in Leadville, and Rob Rose, St. John's in Ouray, and led by lay delegates throughout the Diocese.

Organization of the Convention

The Rev. Mary Kate Rejouis welcomed delegates online, asked that each participant include their parish in the way they are named on-screen, described how to use the features in Zoom to move or second a motion, and how to use a Zoom Poll.

The Rt. Rev. Kimberly D. Lucas called the Convention to order at 10:17 am. The following actions were taken without objection to organize the Convention:

- The Bishop appointed Chuck Theobald Secretary of the Convention
- The Bishop appointed Diocesan Chancellor Lawrence R. Hitt II Parliamentarian of Convention.
- The Bishop appointed the Rev. Rich Paul as Assistant Secretary of Convention.
- The Bishop appointed Carl Peterson and Rick Parker as the Committee to Approve the Minutes of Convention with Canon Mike Orr as consultant.
- The Rev. Nancey Johnson Bookstein was appointed as Chair of the Committee on the Conduct of Nominations and Conduct of Elections.
- The Rev. Wendy Huber was appointed as Chair of the Committee for Legislation and Resolutions. Larry Hitt was appointed consultant to the Committee.
- The secretary reported that a quorum was present in both the Clergy and Lay orders for the Convention.
- The Bishop called upon the parliamentarian for a report on the Proposed Rules of Convention. Mr. Hitt described the rules, which had been posted on the convention web page. Though not required, all actions of this convention will also be ratified at the 135th Convention. The Bishop asked for a motion to approve the rules. The rules were adopted as read.
- The secretary moved the adoption of the agenda as printed. The agenda was adopted.
- The secretary stated that the Committee to Approve the Minutes of the 133rd Convention had approved the minutes of that Convention as posted. He requested the chair receive those minutes. Without objection, the minutes were received.

The Bishop then declared the 134th Convention organized for business.

Affirmation of the Actions of the 133rd Convention

The Bishop called upon the Rev. Wendy Huber for a motion to affirm the actions of last year's virtual convention, in accordance with the special rule adopted by that convention. The motion was seconded by Zoe Cole and the Rev. Mary Kate Rejouis, and was approved.

Elections to Committees and Boards

Standing Committee:

The Bishop called on the Rev. Johnson Bookstein on behalf of the committee on nominations and elections for the election of Standing Committee regional representatives. She introduced the following candidates:

The Bishop called for a vote on the nominees. The Rev. Johnson Bookstein described how to approve the slate using a Zoom Poll. The nominees were elected.

The Bishop asked for a motion to elect the nominees to the Disciplinary Board by acclamation, which was approved, and the nominees elected.

Proposed Amendments to the Constitution of The Episcopal Church

The Bishop called upon the Chancellor to introduce the proposed amendments to the Constitution and Canons of The Episcopal Church. The Canons require all proposed amendments to be presented by the secretary to each diocesan convention. Pandemic Response Video

The Bishop noted that the past year has been full of unexpected challenges, and thanked Canon Carl Andrews for his work as Disaster Director. A video honoring Canon Carl was played for the delegates.

<u>Treasurer's Report and Proposed 2022 Budget</u>

The Bishop introduced the treasurer for his report. Mr. Jay Swope reviewed his written report submitted prior to the Convention and available on the convention web page.

Mr. Swope expressed his thanks for all the parishes and individuals who give to support the Office of the Bishop. He reviewed the major sources of income for 2020 and 2021, including short term increases from the Colorado Trust. Projections for the 2022 budget reflect the expectation that this income will not be sustained next year. He further advised that the diocese is right on track for expenses in 2021. The 2022 budget also anticipates the return of some in-person visitations by the Bishop.

The audit of the 2019 and 2020 financial reports has not been completed, and acceptance of those reports was deferred to the 135th Convention.

The approval of the proposed 2022 budget was then moved, seconded, and approved without further discussion.

The Bishop's Convention Address

The Bishop opened her address with the Prayer for the Unity of the Church from the Book of Common Prayer. She described the stages of her career as an ordained person, and how hard it is to internalize the knowledge that God's Grace is sufficient. God's Grace is enough.

Bishop Kym acknowledged the hard work that has gone into keeping the Church functioning in a global pandemic. And the virus just keeps coming. She used an analogy to the Oregon Trail. After you have survived the tribulations of the journey, you come to a point where you have to decide what to keep and what to discard. You cannot make that decision in St. Louis, at the beginning of the trail. You have to make it on the journey, in the moment.

We in the Episcopal Church in Colorado are at our Oregon Trail moment. We have to decide what is essential to the mission, and what we can let go of. We must be grounded in the Truth that God's Grace is sufficient. She described how the roles of those in the Office of the Bishop are changing to meet the future we seek.

She then challenged the delegates to work to form and focus communities rooted in Christ. Never conflate the kingdom of the church with the Kingdom of God. We do not live in time of certainty, and our faithfulness and discipleship are not free from pain and sacrifice. The process will require difficult conversations, and for us to listen to those not listened to. Then we as the body of Christ we can take the next faithful step, trusting always that God's grace is sufficient. If we give our gifts and talents to God, we will live the way we pray, and we will change the world.

She expressed special thanks to Kory Caudill, Wordsmith, and everyone who participated in the "Concert for the Human Family" and opening event. She acknowledged and thanked our workshop leaders and our keynote speaker, the Right Rev. Jennifer Baskerville-Burrows, Bishop of the Episcopal Diocese of Indianapolis.

A motion to adjourn the 134th Convention was moved and seconded. The Bishop blessed the assembled people of the church. The motion to adjourn was approved. The Bishop declared the Convention adjourned at 12:24 pm.
