Minutes of the 135th Annual Convention of The Episcopal Church in Colorado

Saturday, October 8

A Pre-Convention session was held online. Delegates and others were invited to attend several informational workshops and a hearing on the Proposed Budget.

Thursday, October 13

Opening worship was held at the Convention Center.

Friday, October 14

On Friday, time was dedicated to workshops and regional and parish conversations. That evening, the Rev. Canon Natalie Hall, from the Episcopal Diocese of Pittsburgh, gave our keynote address. Canon Natalie gave a moving account of church planting among people with little church experience and growing congregations in surprising ways.

Saturday, October 15: Business Meeting

At 9:00 am, Bishop Kym welcomed the Convention and recognized the indigenous siblings—Cheyenne, Ute, Lipan Apache—who first inhabited the land where we were gathered.

Deacons the Rev. Jan Pearson and the Rev. Nadine Pope led morning prayer.

Organization of the Convention

Bishop Kym called the Convention to order at 9:17 am. She appointed Br. Scott Michael Pomerenk BSG as Secretary of Convention, Diocesan Chancellor Mr. Lawrence (Larry) R. Hitt II as Parliamentarian of Convention, and the Rev. Deacon Rich Paul as Assistant Secretary of Convention.

Bishop Kym appointed Mrs. AliceMarie Slaven-Emond and the Rev. Tim Backus to the Committee to Approve Minutes for the Convention, with Canon Mike Orr as a consultant.

Bishop Kym appointed the Rev. Nancey Johnson Bookstein as Chair of the Committee for the Conduct of Nominations and the Committee for the Conduct of Elections and the Rev. Mary Kate Rejouis as Vice Chair of the same committees.

Bishop Kym appointed the Rev. Wendy Huber as Chair of the Committee for Legislation and Resolutions, with Chancellor Larry Hitt as a consultant.

The Secretary reported that a quorum of both Clergy and Lay delegates was present.

The Parliamentarian drew the Convention's attention to the Special Rules of Convention and highlighted important points; the Convention voted to adopt the Special Rules.

The Secretary moved the Agenda for Convention, which the Convention accepted.

The Secretary reported that the Committee to Approve the Minutes of the 134th Convention had reviewed and approved the minutes of the previous year's Convention and that the minutes had been posted on the Convention web page. The Secretary submitted the minutes, and the Bishop received them.

Bishop Kym declared the Convention organized for business.

The Rev. Wendy Huber moved that the Convention ratify all actions and decisions made at the 134th Convention, which had been held virtually due to the ongoing COVID pandemic. The motion passed.

Election of Regional Representatives to Standing Committee

The Rev. Nancey Johnson Bookstein, Chair of the Conduct of Nominations and Conduct of Elections, presented the nominees for Regional Representatives to the Standing Committee.

Clergy nominees were:

- The Rev. William Stanton, St. Alban's, Windsor: clergy representative to Front Range Region, to a term expiring 2025 (*Canon 6 sec 3*)
- The Rev. Jeremiah Williamson, Grace and St. Stephen's, Colorado Springs: clergy representative to the Sangre de Cristo Region, to a second term expiring 2025 (*Canon 6 sec 3*)

Lay nominees were:

Deacon Nancey gave the Convention instructions on how to vote.

While voting took place, a video of All Saints, Loveland, was shown.

All nominees were elected. The Bishop thanked The Rev. Amy Underhill Lythgoe, Rector, St. Luke's, Denver, President and clergy representative, Front Range Region; Rick Parker, All Saints, Loveland, Secretary and lay representative, Front Range Region; and Janet Johnson, St. Peter's, Basalt, lay representative, Northwest Region, for their completed terms of service.

Election of Disciplinary Board

Deacon Nancey presented the nominees for Disciplinary Board, terms to expire December 31, 2025 (*3 yrs Canon 7A*):

Reading of Proposed Amendments to the Constitution of The Episcopal Church

Chancellor Larry Hitt informed the Convention that the Canons of The Episcopal Church require the Secretary of each diocesan convention to read in full the language of proposed amendments to the Constitution of The Episcopal Church, and noted that Br. Scott Michael had read the proposed amendments in a video on the Convention website.

General Convention Deputation Presentation

Bishop Kym reminded the Convention that General Convention had been postponed from Summer 2001 to July 7-14, 2022, in Baltimore, Maryland. She noted the Deputation report on the Convention webpage prepared by Deputation Co-Chairs the Rev. Melissa Adzima and Mr. Larry Hitt. Bishop Kym thanked the General Convention deputies.

Election of General Convention Deputies

Deacon Nancey presented the nominees for Deputies to General Convention and explained the voting process.

While voting took place, a video of St. Matthew's, Grand Junction, was shown.

Treasurer's Report and 2023 Diocesan Budget

Mr. Jay Swope, Diocesan Treasurer, made his report to Convention. He briefly explained the reasoning for the 2023 budget and thanked all who had supported him, especially Diocesan Controller Pam Greenfield.

A motion was made to adopt the proposed budget for 2023. After a few questions for Jay, a vote was taken, and the budget was adopted. Bishop Kym thanked the Treasurer, Standing Committee, Finance Committee, and Office of the Bishop staff for their work in drafting the budget.

Election of Diocesan Treasurer

Deacon Nancey presented the nominee for Diocesan Treasurer: Nancy Jones, a member of St. Michael's, Colorado Springs; she was elected.

Legislation and Resolutions Committee

The Rev. Wendy Huber, Chair of the Legislation and Resolutions Committee, presented Resolution #1: The Care of Creation Resolution. The Rev. Dr. Gary Brower, one of the proposers of the resolution, spoke to it from the floor.

After a brief discussion, a vote was taken, and the Resolution was adopted.

A video was shown of St. Mary Magdalene, Boulder.
