Significant Property Issues

Approved additional resources to Cathedral Ridge for needed repairs and as a bridge loan while a new property insurance carrier was put into place

Numerous Parishes requested assistance in gaining approval for various grants and/or loans that would enable them to complete necessary repairs and construction projects. The Standing Committee worked alongside the Diocesan Property Committee to ensure that these requests were in compliance to Diocesan canons and procedures

Mission Leadership Review

During the Spring of 2024, the Standing Committee, in collaboration with Bishop Kym, coordinated the Mission Leadership Review for the Diocese of Colorado. The review was an opportunity solicit feedback and various perspectives regarding our life as a Diocese under Bishop Kym's leadership. A series of conversations and interviews were conducted by Rev. Gay Jennings, past President of the Executive Committee for the National church, with members of the Standing Committee, Regional Missioners and Executive Boards as well as members of the Bishop's Staff. The resulting feedback has been shared with the Standing Committee and a summary report has been prepared for distribution to the Missioners and Regional Boards.

Looking ahead

The Standing Committee continues to explore ways to work more closely with both Parishes and members of the Bishop's staff to support the vitality of our institutions and Parishes within the Diocese. This work has taken the form of beginning a thorough review of our Canons and procedures to ensure that they are more truly responsive to our post-Covid lives together. While this work is tedious and does not hold the promise of quick results, it is important that careful discernment lead to constructive adjustments in our structure that will reflect the flexibility needed to continue the remarkable work being accomplished within the Diocese. Along with our continued collaboration with the Regional Missioners and Regional Executive Board members, the Standing Committee remains focused on providing a voice for the member parishes of this Diocese.
