**Executive Summary**

St. Benedict Health and Healing Ministry envisions a community where suffering is alleviated, and health and healing are available to all. We accomplish our ministry with an all-volunteer clinical staff who share our values of respect, hospitality, compassion, and integrated care for the body and spirit. In the past year we provided the most care ever in our history with over 2507 medical services. Services included: Acute Illness – 47, Wound Care – 142, Blood Pressure Checks – 617, Glucose Checks – 253, Physician consults – 227, Nurse consults – 572, Foot Care – 68, Vaccines – 378, Rx medications – 79, Over-the-counter Medicines – 514 (Tylenol, Advil, Antacids/Tums, Cortisone and Antibiotic ointments, Benadryl, etc.) We gave out over \$51,000 in preventative care/personal hygiene items for 4375 individuals.

Free medical care that is accessible, culturally and linguistically responsive, and requires no documentation continues to be more needed than ever. For our safety net clinic partners across the state, the Medicaid roll-offs resulted in large numbers of individuals who previously had coverage left with no health insurance. For Clinica, which is the largest safety net clinic in the state, more than 16,000 of their clients were left without insurance. People still require medical care, so this has placed a huge burden on providers of free/no-cost care. As Clinica has closed clinics, ended community outreach programs, and laid off employees, St. Benedict Health was asked to step up and help fill the gaps. We have done this to the best of our ability but need continued and expanded funding to meet the need. With the loss of Medicaid benefits coming in 2026, now more than ever, we need your support!

As we continue to evolve as an organization and the need for our services grows, we are grateful for and rely on the support of our Episcopal Churches.
